

SEX OFFENDER SENTENCING IN WASHINGTON STATE: COMPARING CHARGES FILED TO CONVICTIONS

The 2004 Legislature directed the Washington State Institute for Public Policy to analyze the impact and effectiveness of current sex offender sentencing policies.¹ Because the topic is extensive, we are publishing a series of reports.

As explained in a previous report, recidivism is the commission of any offense committed after release to the community that results in a Washington State court legal action.² The role of plea bargaining³ in criminal cases raises an issue concerning the degree to which measuring recidivism by using convictions under-represents sex offending.

This report examines the extent to which the original charges filed in a Washington State Superior Court felony sex offense case differ from the final convictions.

After an arrest by law enforcement for a felony offense, the prosecuting attorney is responsible for deciding whether to file a criminal case in Washington State Superior Court. If the prosecutor decides there is sufficient evidence for a felony offense, the case is filed citing the specific charge(s) from the Revised Code of Washington. As the prosecutor develops the resulting court case, an initial charge may be amended to a less or more serious charge. The offender is convicted of the charge by pleading guilty or being found guilty. This report compares the initial charges to the charges that result in a conviction. Differences between the initial and final charges may result from plea bargaining or a change in evidence supporting the initial charges.

The study sample consists of cases filed in Washington State Superior Court between 1992 and 2002 that involve an initial felony sex offense charge. The sample ends in 2002 to allow sufficient time for all cases to be adjudicated.

SUMMARY

This report examines the extent to which the original charges filed in a Washington State Superior Court felony sex offense case differ from the final convictions.

Findings

- **Approximately 8 out of 10 cases filed in Washington State Superior Court involving a felony sex offense result in a conviction.**
- **Seventy-five percent of the convictions for these sex offense cases are for felony sex offenses, and another 13 percent are for violent felony offenses. As a result, nearly 90 percent of convictions are for either felony sex or violent felony offenses.**
- **Including misdemeanor sex or violent convictions in the total increases convictions for any sex or violent offense to 97 percent.**

This report supports the decision to combine violent felony convictions and sex offense felony convictions to measure recidivism. By doing so, it takes into account many crimes that were initially filed as sex offenses but, because of a plea agreement, resulted in a conviction for a lesser offense. Thus, this measure is more sensitive than an exclusive focus on sex offenses, and takes into account criminal behavior that is of significant concern to the public.

Exhibit 1 shows how felony sex offense cases are categorized into three types: child sex, rape, and other felony sex. If a case involves multiple sex charges, child sex takes precedence over rape, which takes precedence over other felony sex offenses in this categorization.

**Exhibit 1
Felony Sex Offense Categorization**

Category	Sex Offenses
Child Sex	Child Molestation, Rape of a Child, Communicating With a Minor for Immoral Purposes, Incest, and any other felony sex offense involving a child
Rape	Rape 1, Rape 2, and Rape 3
Other Felony Sex	Felony Indecent Liberties, Felony Voyeurism, etc.

Exhibit 2 shows the percentage of felony sex cases filed from 1992 to 2002 that resulted in a conviction. The percentage of child sex cases resulting in a conviction remains constant at approximately 80 percent. The rape conviction rate varies between 70 and 80 percent, while the conviction rate for other felony sex offenses has been increasing since 1996.

That is, between 15 and 30 percent of cases involving a felony sex offense do not result in a conviction. This means there was insufficient evidence to conclude that the offenders were guilty as charged.

Percentage of Felony Sex Offense Filings Resulting in a Conviction**




Exhibit 3 examines the 7,865 cases involving a felony sex offense that were filed in the five-year period from 1998 to 2002. Overall, 82 percent of those cases resulted in a conviction.

Of these convictions, 75 percent resulted in a felony sex offense conviction, and 13 percent resulted in a violent offense conviction. Thus, 88 percent of the cases had either a sex or other violent felony conviction. An additional 9 percent had either a misdemeanor sex or misdemeanor violent conviction; thus, 97 percent of sex offense cases include convictions for sex or violent offenses.

That is, almost 90 percent of sex offense cases resulting in a conviction have a sex or violent felony conviction, and nearly all cases have a sex or violent conviction.

Exhibit 4 examines trends in the types of convictions for sex offense cases filed between 1992 and 2002. The purpose is to determine if trends exist that could confound comparing groups of offenders convicted at different points in time.

For rape filings, the percentage of felony sex offense convictions decreased from approximately 50 percent in 1992 to 40 percent in 2002. During the same period, convictions for other violent felony offenses increased. As a result, the percentage of cases convicted of either a sex or violent felony has no discernible trend.

For sex crimes against children filings, the percentage of sex offense convictions has decreased slightly, from nearly 80 percent in 1992 to approximately 70 percent in 2002. Since convictions for other violent felony offenses are low for child sex offenders, the percentage of sex plus violent convictions is only slightly higher than felony sex convictions.

For other felony sex filings, the percentage of sex offenses and violent felonies dipped in 1994 and 1995, but there has been no evident trend since then.

Exhibit 4 shows there are no discernible trends in the percentages of sex offense cases resulting in either a felony sex or other violent felony conviction. That is, there are no trends that may affect the analyses of groups of sex offenders from different time periods.


The Appendix displays 12 tables of information for sex offense cases filed between 1998 and 2002.⁴ Each table includes cases involving a specific initial charge. For example, Table A-1 shows the 345 cases filed with a Rape 1. The tables then list the percentage distribution of the most serious conviction in each case. To illustrate, 31.9 percent of the 345 Rape 1 filings resulted in a Rape 1 conviction. The tables also include cumulative percentages. For example, 51.6 percent of the Rape 1 filings resulted in conviction for some type of sex offense, and 81.7 percent resulted in a conviction.

These tables offer detailed insight into plea bargaining in felony sex offense cases. They show how often the initial charges differ from the final charges, as well as the final conviction.⁵ The tables can be used to confirm or refute notions about plea bargaining in felony sex offense cases.
